

## Transportation Reimbursements

If your child is transported to and from a non-public school at your expense and is eligible for reimbursement, you may, through your school of attendance, request reimbursement for transportation.

Minnesota State Law specifies that students attending out of district non-public schools are eligible for transportation services or reimbursement for transportation to the district boundary if you live more than 2 miles from non-public school and is transported by parent or non-public school bus.

1. **Call OR go online to obtain the Non-Public School Transportation Reimbursement Contract (as noted below).**
2. **Please fill it out promptly and email or mail to your local school district (as directed).**
